It is imperative to get the 100% yes vote, so if anyone voted "no", please change your vote to "yes". Otherwise, AAUW California will move into a complex and costly appeal process with the state. EDUCATION Gayle Duncan

The Mt. Diablo Unified School District has partnered with Classroom Champions to bring Olympians and Paralympians to be mentors at eight elementary and middle schools. Classroom Champions is an international education nonprofit organization that targets classrooms in underserved communities. It is hoped that in addition to the mentoring, students will be rooting for Team USA, during the winter Olympics, with their "insider knowledge" learned from the athlete mentors. Mt. Diablo is the first district, in the country, to be a Champion District. There are 24 teachers and classrooms participating in the program. The organization was co-founded, in 2009, by Olympic Gold Medal bobsledder, Steve Mesler and Dr. Leigh Mesler Parise. The program is available for K-8 classrooms in publicly funded schools. American and Canadian athletes interact with students through live and recorded video chats. Teacher training is provided to coordinate the monthly video messages with classroom curriculum. Topics include lessons on goal setting, perseverance, courage, fair play, and leadership, to name a few. Students share photographs and monthly summaries with athletes and other participants, through an internal online network. Students react positively when the athletes are announced at the beginning of the school year. They especially get excited when they see the athletes' medals. A digital relationship is formed as the students follow the athletes who are constantly encouraging them. The sixth-grade program coordinates with the curriculum that includes: Greece, math, and health, among other subjects. Especially important are the life skills that are taught. Many students have siblings with disabilities and the program helps them to express their struggles at home. Diversity is another important topic. Students learn how to set goals that will help them achieve their dreams. They learn to appreciate diversity and value their communities and the world around them. Students with a physical disability have learned the meaning of "Paralympic," the Paralympian symbol, and "disability." The students can connect with para Alpine skier Tyler Carter and learn that, despite his right leg being amputated below the knee, he can ski. The athletes also provide positive role models for female and male students, who otherwise may have only negative influences in their lives. The program also encourages students that it is ok to make mistakes, and be wrong, but if they "persevere" as the athletes have done, they can be successful. The 2018 Women's Marches across the Country focused on getting women to vote. If anyone is interested in helping to register voters, I would be happy to get the information and organize a registration drive amongst our AAUW group and in a public location.

From National AAUW:

This year marks the 45th anniversary of the <u>landmark</u> U.S. Supreme Court case *Roe v. Wade*, which legalized abortion in the United States. Research has shown that access to safe and legal <u>reproductive</u> health care, including abortion, fosters self-sufficiency, promotes preventive health care, and protects individuals and their families from the spread of sexually transmitted infections.

But control over one's reproductive life is also part and parcel to achieving <u>economic autonomy</u>; without reproductive choice, women cannot attain equal pay or opportunity in the workforce. The existing pay gap already hurts women, their families, and the economy. Limiting reproductive choices and access only compounds these issues.

On the anniversary of *Roe v. Wade*, we celebrate our freedoms and look to a future in which increased access to critical health care leads to greater economic security and parity for women. But that future is not secure—just this week, the House of Representatives <u>passed</u> a bill that would undermine access to abortion. In addition, the U.S. Department of Health and Human Services ramped up efforts to expand providers' ability to refuse access to abortion services, birth control, and other health care; and rescinded guidance explaining that state efforts to block patients' access to care at <u>Planned Parenthood health centers</u> violate federal law. AAUW will continue to <u>advocate</u> for women's access to reproductive health care, and oppose efforts to restrict it.

On January 12th I received this email from National:

Bits and Pieces

- A federal court on Tuesday <u>ruled</u> that North Carolina's congressional districts had been unconstitutionally drawn to give Republicans a political advantage. The ruling ordered the state legislature to redraw the districts by January 24.
- On Thursday, the Trump administration <u>announced</u> that states will now be allowed to impose work requirements for Medicaid programs. This decision disproportionately <u>impacts</u> women, who make up 62 percent of those who could lose coverage.
- The Senate this week <u>announced</u> an updated list of committee assignments for the second session of the 115th Congress. New Sens. Doug Jones (D-AL) and Tina Smith (D-MN) are both assigned to the Health, Education, Labor, and Pensions (HELP) Committee, while Sens. Kamala Harris (D-CA) and Cory Booker (D-NJ) <u>made history</u> as the second black woman and first black man appointed to the Committee on the Judiciary.

Happy New Year and welcome to the 2018 legislative session! As of today, legislatures are meeting in 38 states. We're looking forward to working together to pass legislation that will positively impact women and families across the country.

We made a lot of progress last year, with several <u>equal pay</u> victories, advancements in paid sick and family leave programs, momentum on passage of the Equal Rights Amendment, and increased awareness of issues surrounding workplace sexual harassment and assault. We expect these trends to continue and plan on notching many more wins.

We know the successes will continue because <u>women are making it happen</u>. A poll of individuals in the Millennial generation found that women were more likely than men to have reported engaging in political activity during the past year. This trend is apparent across different categories of activism, from engaging online to volunteering to attending public events. This is likely correlated with the finding that there is <u>rising discontent with the position of women in U.S. society</u>; compared to a poll 10 years ago, there is an 11 percentage point increase in that sentiment among all Americans.

Women are fired up and they are increasingly doing something about it. We're excited to work together to harness that momentum and bring about real change in 2018 at the state and local levels.

Paid Leave Laws and Minimum Wage Hikes Go into Effect on January 1

Many state laws successfully passed in previous legislative sessions are going into effect now that the calendar has turned to 2018. Paid family leave protections—new to New York and expanded in California—began on January 1, while Rhode Island, Vermont, and Washington residents now earn paid sick days. With last week's vote to override Gov. Larry Hogan's (R-MD) veto of a paid sick days bill, Maryland workers will also see changes in the coming months. And on April 1, pregnant workers in Massachusetts will have greater access to on-the-job accommodations. Additionally, 18 states instituted minimum wage hikes to start the new year. Many of these increases are incremental bumps toward even higher wages that are gradually taking effect and are much needed in light of a new report from Bloomberg finding that the gap between the earnings of U.S. CEOs and those of average U.S. workers is the widest worldwide.

States Offer Legislative Solutions to the Student Debt Crisis

Approximately 44 million borrowers in the United States hold about \$1.3 trillion in outstanding student loans, and women hold nearly two-thirds of that debt load. Women take on larger student loans than men do, and because of the gender pay gap, they have less disposable income with which to repay their loans after graduation. Many state policymakers are realizing the urgent need to enact reforms and tackle the student debt crisis. Higher Ed Not Debt created a map to track legislative efforts across the country. It focuses on five policy areas: borrower's rights, for-profit college accountability, immigration and higher education, refunding higher education, and student loan refinancing.
