National sends me many, many updates. These seemed to be very important. There were over 700 marches opposing the President's policy of separating families. No matter your political persuasion, separating children (including taking babies off their mother's breast) is very bad for our country.

With all the dividedness in our country we need to be aware of the need for civility and calm discussion. So I'm asking everyone to think of the mission of AAUW and what it means to you and how you can help our country return to civility.

Here are the issues that National has sent me that I feel are important for our consideration.

Yesterday's news that Justice Anthony Kennedy will retire from the Supreme Court marks a pivotal moment in our country's history. In recent years, the Supreme Court has decided cases that have weakened protections critical to the equity of women and girls throughout our country, including rolling back employment discrimination laws and labor rights, undermining reproductive rights, and restricting voting rights.

But we will not be deterred.

Because of you, we've prevailed in critical gender discrimination cases in higher education and workplaces across the United States.

Because of you, we've made major strides in creating a fairer playing field for girls in STEM fields.

Because of you, our powerful AAUW network has mobilized across this country to fight for pay equity for working mothers.

Because of you, we've stood for strong Title IX enforcement despite attempts to weaken it.

We cannot go back. Now more than ever, we need **your support** to ensure that Justice Kennedy's replacement will be a fair-minded, independent jurist who will stand for economic security, educational opportunity, and fundamental rights for ALL women and girls. And we will work with AAUW allies from all political perspectives on Capitol Hill to get a justice who supports our vision — equity for all.

Supreme Court Rules in Favor of Fake Health Care Facilities

On Tuesday, the U.S. Supreme Court reached its decision in *National Institute of Family and Life Advocates (NIFLA) v. Becerra*, ruling 5-4 in favor of NIFLA and reversing the judgments of the lower courts. The decision means that fake health care facilities – referred to as crisis pregnancy centers – are not required to disclose relevant medical information to clients. The controversial case concerned a California law that requires such facilities to disclose through posted or printed materials the availability of low-cost or free family planning services, prenatal care, and abortion services not provided at their facility. The law also requires disclosure if the facility and its staff are unlicensed. NIFLA challenged the law as a violation of free speech protected under the First Amendment, while the State of California argued that the law was necessary to provide women access to accurate reproductive health information and services. AAUW firmly supports every person's right to safe and legal reproductive health care, including abortion, and signed on to an amicus brief in this case that emphasized the harm caused by fake health care facilities failing to disclose accurate, necessary information about reproductive health services.

Justice Kennedy Announces Retirement from Supreme Court

On Wednesday, U.S. Supreme Court Justice Anthony Kennedy announced that he will retire at the end of July, after 30 years on the bench. Justice Kennedy was often a deciding vote in controversial cases, and his successor will have a say in the health, education, and economic security of women and girls for decades to come. Much of AAUW's work fighting for gender equity and the fundamental rights of all hangs in the balance with this Supreme Court vacancy. Any nominee must be the result of meaningful bipartisan consultation, fully vetted by the Senate, and held accountable for any record of bias. A recent U.S. Supreme Court decision in *Janus v. AFSCME* reversed the Court's 1977 ruling in *Abood v. Detroit Board of Education*. The precedent set by *Abood* permitted public employers to collect fees from non-union members because all employees benefitted from their collective bargaining agreements, but the Court ruled in *Janus* that collecting these fees from nonconsenting public-sector employees violates the First Amendment, despite the collective benefits they receive.

In *Abbott v. Perez*, the U.S. Supreme Court reversed a lower court's decision in a Texas gerrymandering case that had held that the state legislature intentionally discriminated against Latino and African American voters in adopting earlier con-

gressional and state house maps. The Court found that the lower court used the wrong burden of proof by requiring the state to prove a lack of intent to discriminate, rather than compelling the plaintiffs to prove the redistricting plans had discriminatory intent. In addition, the Court reversed findings of violations of the Voting Rights Act and racial gerrymandering, holding that only one of the challenged state house districts was an unconstitutional racial gerrymander.

A problematic immigration bill failed in the U.S. House of Representatives this week, falling short by nearly one hundred votes. The bill proposed funding for a border wall and increased security, ending the diversity visa lottery program, restricting family-based immigration, and an inadequate pathway to citizenship for recipients of the Deferred Action for Childhood Arrivals (DACA) program. AAUW joined a letter opposing this and an earlier House immigration bill, both of which were considered and failed over the past two weeks. We continue to urge Congress to take up and pass the bipartisan Dream Act.

AAUW joined an effort to petition the U.S. Department of Education to retract and correct the 2017 Title IX Dear Colleague Letter on Campus Sexual Misconduct. The Department's 2017 letter contains many inaccurate or misleading statements, all without citation, in violation of requirements of the Information Quality Act.

Please consider how all these decisions will affect you, your family, your community and our nation.

TECH TREK TIDINGS

Our members were pleased to be able to meet all five girls and their families at the end of the year brunch on June 2. We will be anxious to hear about their camp experiences at the Fall brunch. The Ice Cream social was a huge success. There were about 25 future trekkers from 7 local branches in attendance. Katrinka facilitated the ice breaker with the girls getting into teams and building a structure using playing cards. They quickly mingled and completed their task, sharing with the other groups what their team created.

I was fortunate to be able to attend camp again this year as a class monitor, for 3 days this time. I joined the campers on two field trips. The first was to Ellis Creek Wastewater Treatment Plant in Petaluma, where we not only toured the plant but did some bird watching guided by members of the Petaluma Wetlands Alliance in the nearby wetlands. They even had binoculars for us to use and a spotting scope, amazing to see the red-shouldered hawk up close protecting its nest and tree swallows swooping in and out of their nesting boxes. The second trip was to Sonoma County Water Agency education center at the Russian River. After a walk through the riparian zone, along the river we viewed the fish ladder, but alas none swimming by. There was however, a black phoebe feeding babies in her nest, tucked in the rafters. Of the five Core classes offered I monitored Aerospace Engineering, Biology Wet Lab, and Engineering. In Aerospace Engineering the girls were learning about the force of flight, lift, weight, thrust, and drag. They made hot air balloons in the previous day class and experimented with balloon rockets to understand Newton's Third Law of Motion. I also peeked in on the class the following day as they were dropping Barbies, attached to rubber bands, off the second floor into the lobby. In the Biology Wet lab the topics were kidney dialysis, diffusion, egg osmosis, and frog dissection. Engineering core class was busy building Mousetrap Cars after constructing roller coasters for marbles. It was wonderful to see and feel the positive energy throughout the camp.

Thank you to our co-directors Jeanne Benedetti (San Ramon) and Rory Keller (Petaluma) for orchestrating a fabulous camp, building experiences and memories Tech Trekkers will cherish for forever. The opportunity would not be possible without the dorm moms (especially our own, Trinkia March), classroom teachers, counselors and all those who volunteer at camp (Penny Harris), and behind the scenes, and of course to all your monetary donations.



2018 AAUW National Bylaws Amendments Vote Results

(from the AAUW National website and an email)

Thank you for voting on the three proposed amendments to the AAUW Bylaws in the 2018 National Bylaws Amendment Vote. We had a great turnout this year with over 19 percent of eligible members participating in the vote, more than three times the 5 percent required by our bylaws. Thank you for making your voice matter on these important issues.

The percent affirmative below have been updated as they were previously miscalculated in error. A choice of 'abstain' is not a vote, therefore the number of 'abstain' have been removed from the total from which the percentages were calculated. The correct percentages are now reflected. The vote totals have not been changed.

Proposal 1. re: Staggered Terms	Yes	96.61%	13584	477	550	113
Proposal 2. re: non-AAUW Members on Board	No	54.47%	7110	6188	1310	116
Proposal 3. re: Degree Requirement	No	47.73%	6503	7121	997	103

Proposal #1 to create staggered board terms passed. Staggered terms will affect elected and appointed AAUW Board members starting terms in 2019. More information will be available during the application and election periods in the coming year, and the AAUW Governance Committee will work closely with the AAUW Nominating Committee and staff to ensure a smooth transition.

Proposal #2 to allow non-AAUW member eligibility to Board did not meet the percentage required to pass.

Proposal #3 to remove the educational requirement to AAUW membership did not meet the percentage required to pass.

A two-thirds vote is required to pass a bylaws amendment. 19.82% of eligible voters cast a ballot, nearly 4 times the required quorum of 5%, and up from 11.5% at last year's convention.

A Note from Muriel Fry - Voting on "Daylight Savings Time"

There is a possibility of voting in November about "Daylight Savings Time".

Here is a phone number to encourage Governor Brown to sign a bill currently on his desk to allow this subject to be on the ballot. 916-445-2841

This number works. I was able to speak directly to one of his representatives. I could have had his email. I said my name and that I was calling urging Governor Brown to sign the bill which would allow me to vote on Daylight Savings Time. He indicated he would report that to Mr. Brown.
