Director John Burgh will provide an overview of the Contra Costa Water District, including governance and service area, as well as discuss updates to operations during the pandemic and planned infrastructure projects to keep our promise of 24/7 service and reliable, high quality water.

His presentation will include an overview of the programs—past, present , and future—that the Water District has implemented to make sure we have good , safe drinking water. We have heard that the Pandemic has affected the work and the programs of the Water District in some ways, and look forward to learning from Mr. Burgh what updates and infrastructure projects are planned to keep their promise of 24/7 service and reliable high quality water.

John Burgh has served on the Contra Costa Water District Board of Directors since 2004, representing Pleasant Hill, Martinez, Port Costa and a portion of Concord. He will serve through 2022.

He is a retired engineer who has worked on water and wastewater projects throughout the world. He has a total of 42 years of experience in the administration, project management, and design of public works projects. For the last 30 years of his career, he worked for an environmental engineering consulting firm, where he retired as Vice President.

He holds a Bachelor of Science degree from the University of Notre Dame and a Masters in Management degree from the University of New Mexico. He is a registered civil engineer in California and a Diplomate of the American Academy of Environmental Engineers and Scientists. He is an Air Force veteran.

He is a past President of the Contra Costa County Historical Society. A resident of Concord for over 30 years, he is a member of the Pleasant Hill Rotary Club and is a volunteer driver for Meals on Wheels, delivering meals to shut-in senior citizens in the area. His hobby is restoring old Studebakers. He is active in the national Antique Studebaker Club.
